Absence of the applicant or their authorized representatives, however, shall not obstruct or prevent the opening of the bidding in any way and must be accompanied by bid security of NRs. 1,30,000/- deposited in Account No. Ko.Le.Ni.Ka. 120120 000 100 2524 and office code number 27-308-09 of Nepal Rastra Bank, Kathmandu or in the form of unconditional Bank guarantee from class A bank in favor of **NHPDC, Thapagaun, Kathmandu**, which shall be valid for minimum 30 (thirty) days beyond the bid validity period.
